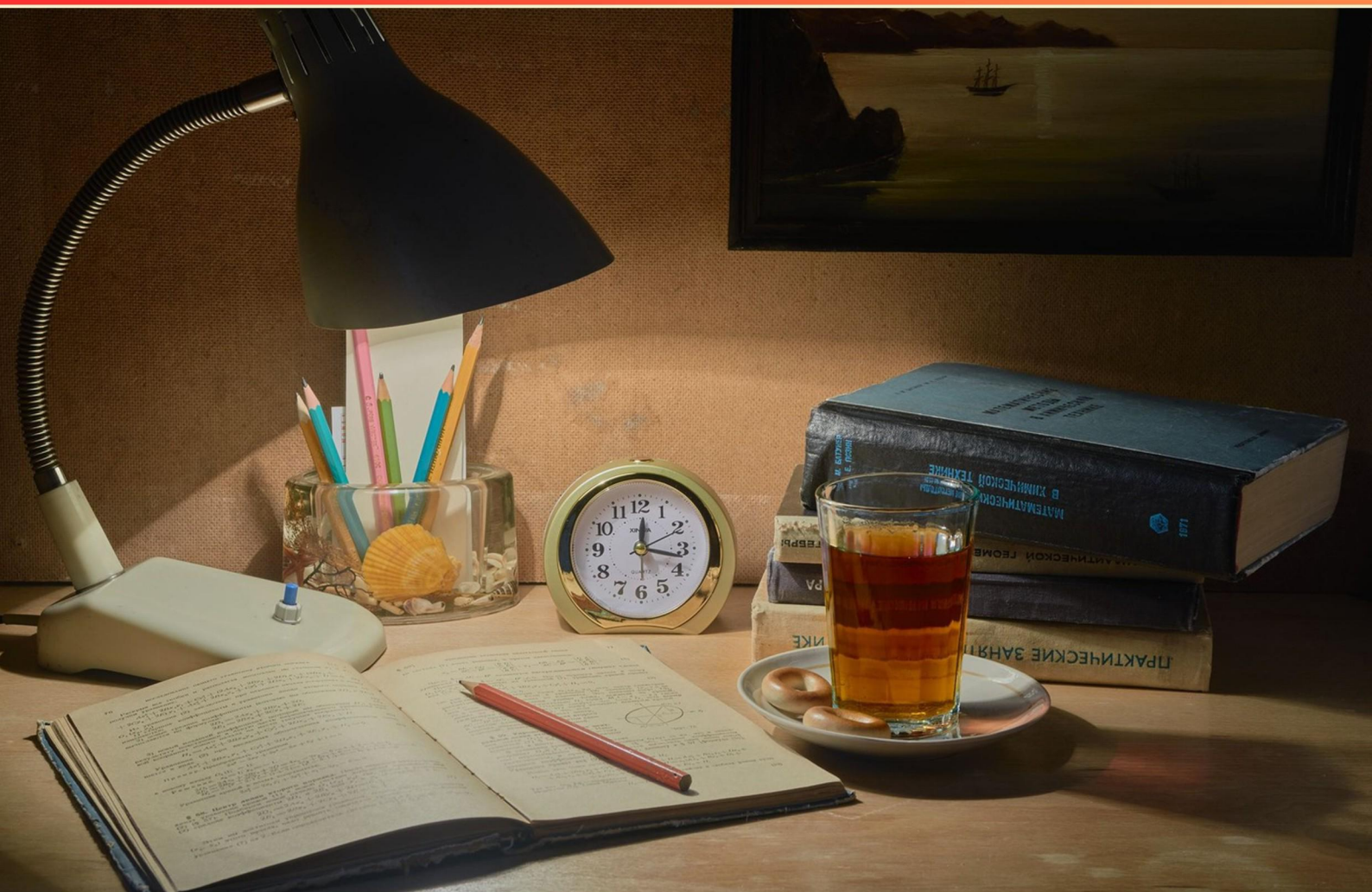

1. Name a Hawthorne work that critiques Puritan hypocrisy and the role of sin in community life.

- A. The Minister's Black Veil

This question is about recognizing how Hawthorne targets Puritan hypocrisy and the way sin functions within a community. The Scarlet Letter is the clearest example because it places a moral drama inside a strict Puritan town and shows how the community uses outward symbols of virtue to police behavior while hiding private guilt. In the novel, Hester Prynne bears the scarlet letter as a public mark of her sin, and the town's reactions—the gossip, the scorn, the scaffold—reveal how sin becomes a social instrument to define identity and enforce conformity. Yet Hawthorne also exposes the gap between outward piety and inner life. Dimmesdale, the minister, hides a private sin that torments him, while Chillingworth embodies a vengeful sin that corrodes moral integrity. The clash between public judgment and private guilt exposes the hypocrisy at the heart of the community's religious authority and social norms. The symbol of the letter itself shows how sin is used to control behavior and shape communal life, often more to maintain appearances than to pursue true virtue. Other Hawthorne works touch on related ideas, but they don't center the critique of Puritan hypocrisy and social life as directly. The Minister's Black Veil, for instance, focuses on personal guilt and secrecy within a single minister and his immediate circle. The House of the Seven Gables emphasizes inherited sin within a family saga rather than Puritan communal life. Twice-Told Tales is a collection of stories, not a single extended examination of Puritan society. The Scarlet Letter remains Hawthorne's most direct and expansive treatment of how sin and hypocrisy operate within a community.

The main idea here is recognizing which poet best embodies the Harlem Renaissance and uses poetry to critique social injustice. Langston Hughes stands out because he was a leading voice of the Harlem Renaissance in the 1920s, blending jazz-inspired rhythm and everyday speech to depict Black life in America while openly challenging racism and inequality. His poems connect personal experience to broader social issues, from hope and dignity to the harsh realities of segregation. Examples like "I, Too" affirm Black worth and inclusion; "Harlem" asks what happens to dreams deferred, capturing the movement's spirit of confronting social limits; and "The Weary Blues" powerfully conveys the fatigue and beauty of Black urban life. The other writers listed are important figures in Black literature, but they are associated with different periods or genres (Maya Angelou with later civil rights-era poetry and memoirs; James Baldwin and Ralph Ellison with mid-20th-century novels and essays), so Hughes is the one most closely linked with the Harlem Renaissance and its social critique.

The big idea here is how a single emblem can embody guilt and invite public judgment. The Scarlet Letter centers its entire theme on a visible symbol—the scarlet letter worn by Hester Prynne—which the Puritan community reads as a public declaration of her sin. That one object makes guilt unavoidable and shapes how society treats her, how she contends with that judgment, and how meaning around the symbol evolves as the story unfolds. Other works in this set use their plots to explore different concerns or rely on varied devices, so they don't hinge on a lone object used to publicly render guilt. A story about a social gathering, one about personal or wartime ethics, and a suspenseful tale of risk don't revolve around a single symbol that embodies and broadcasts guilt to the community in the same central way.

The other writers mentioned are notable for different focuses. One is known for novels about mid-20th-century suburban life and private, personal themes rather than broad social protest. Another wrote about wealth, disillusionment, and the Jazz Age in the 1920s, not the migrant-crisis narrative of the Grapes of Wrath. The last is a major Southern writer whose concerns lie in legacy, identity, and race within a different regional context, not the Grapes of Wrath.

The poem reflects a Christian perspective and addresses the idea of salvation for Africans, a theme Wheatley presents in her work. The other poets listed wrote in different times and styles: Henry Wadsworth Longfellow is a 19th-century American poet known for narrative and epic works; Anne Bradstreet is a 17th-century Puritan poet who wrote about religious and domestic life; Paul Laurence Dunbar is a late 19th/early 20th-century African American poet known for dialect and social themes.

The main idea is a pointed critique of industrial capitalism and the exploitation of immigrant workers in the meatpacking industry. Sinclair uses the experiences of a Lithuanian immigrant family to reveal how profit-driven plants force unsafe, unsanitary conditions, brutal hours, and wages that keep workers trapped in poverty. The aim is to lay bare social injustice and push for reform, rather than praise aristocratic wealth, claim reformers already fixed the problems, or celebrate immigrant culture. So the strongest answer highlights the brutality and exploitation at the heart of the meatpacking system under capitalism.

7. The line 'clatter, pop, and bang' is labeled as which device in the material?

Onomatopoeia is the device where the word imitates the sound it describes. In "clatter, pop, and bang," each word mimics a real sound: clatter suggests a rattling noise, pop is the sound of something bursting or snapping, and bang is a loud crash. Using these sound-imitating words creates a vivid auditory effect for the reader. Assonance is about repeating vowel sounds within nearby words, not about the words themselves representing sounds. Metaphor makes a direct comparison between two unlike things without using like or as, which isn't what these words are doing. Rhythm refers to the pattern of beat or cadence in a line, and while the sequence may contribute to rhythm, the primary device here is the imitation of actual sounds—onomatopoeia.

*Washington Irving is the author who first earned broad international recognition. The delightfully accessible prose, humor, and distinctly American settings helped European audiences see American storytelling as serious literature, not just local folklore. That early international visibility set Irving apart from later American writers and helped open doors for American authors on the world stage. The other figures are influential in their own right but did not achieve that level of early, wide international literary recognition.*

9. The phrase 'Sho' nuff, Brer Fox lif' up his foot en holler wahao!' demonstrates which literary device?

Using dialect in dialogue to reveal voice and setting is what this line is doing. The spellings like Sho' nuff, lif' up his foot, en holler show phonetic representations of Southern regional speech, capturing Brer Fox's way of talking. This emphasis on pronunciation, vocabulary, and rhythm communicates the character's background and the story's cultural context, not just what happens in the scene. It isn't presenting a direct comparison (that would be a simile), and it isn't aiming to imitate a particular sound effect as onomatopoeia does, nor is it standing for a larger idea as a symbol would. So the line best demonstrates dialect.

Understanding attribution of a line hinges on recognizing the poet's distinctive voice and themes. If the line you're considering carries that calm, meditative quality, it fits Nicholson's style more than the others: Elizabeth Scott Stam's writing often centers on faith and martyrdom, Robert Frost's poetry leans toward nature and rural life with a conversational, narrative voice, and Marianne Moore's work is noted for precise, formal craft and often ironic or cerebral tone. So the line is most plausibly attributed to Martha Snell Nicholson.
