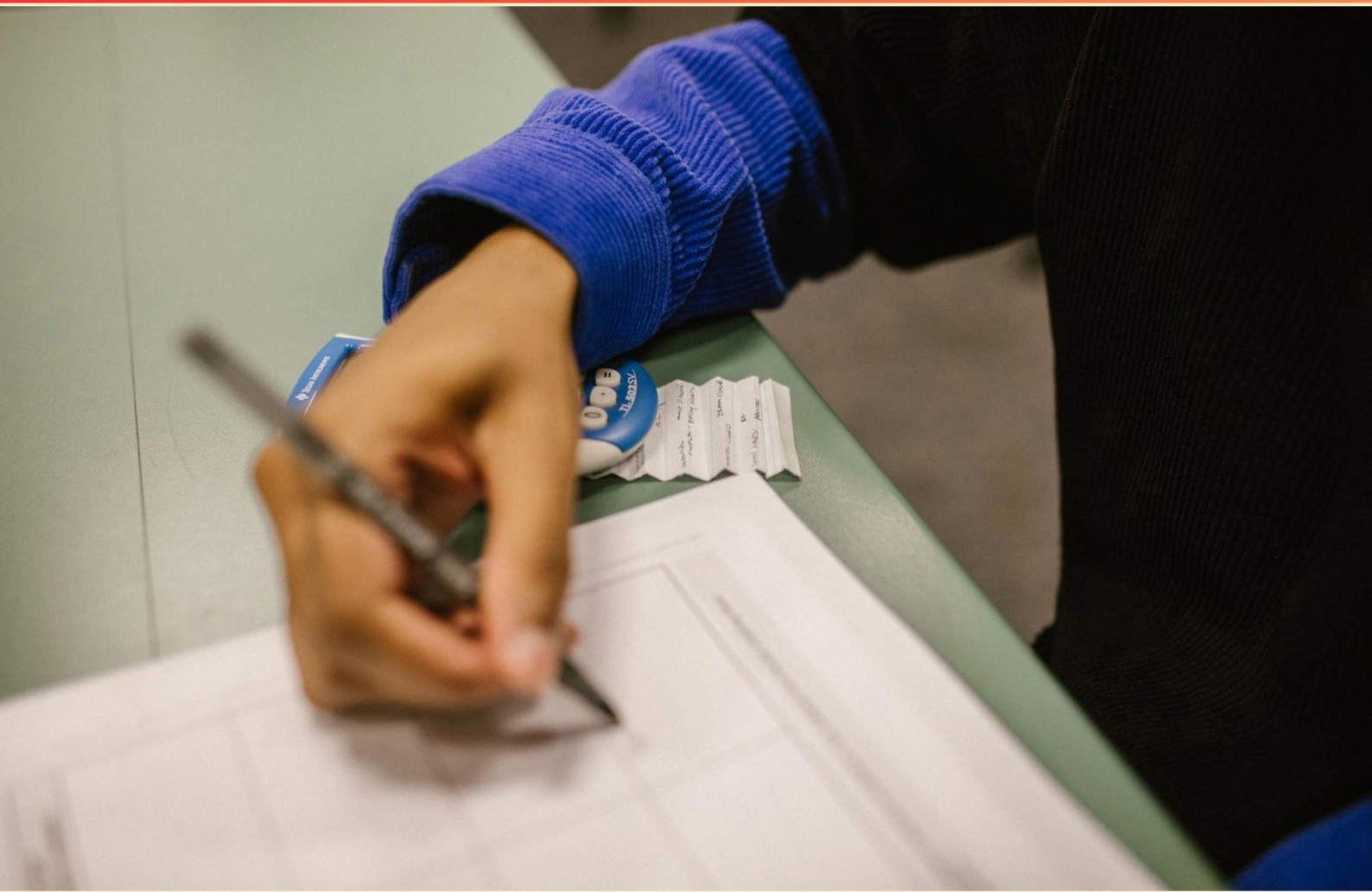

Myrtle runs into the street as a spontaneous move to confront the person driving the yellow car and to grab his attention. She believes the car will bring her face-to-face with Tom, the man she wants to see, and she uses this dramatic gesture to reach him and press him to acknowledge her life and desires. This moment highlights her urge to escape her ordinary life through the world of wealth and status Tom represents, rather than simply trying to escape poverty, help a friend, or retrieve something lost.

Seeing this as a late candidate helps explain how Fitzgerald was honing the book's thematic frame just before locking in the final title.*

When Gatsby's character becomes fully realized, the book's emotional resonance and moral dimension come through, guiding the ending and the narrative's power. The other aspects—prose style, an unsatisfying ending, or an exotic setting—weren't the primary concern Perkins identified; he focused on shaping Gatsby himself so the novel could truly endure as a character-driven work.

This image of a liberated, nonconforming woman and poet carried through her famous circles in the 1920s and her outspoken stances on liberty and individual rights. That makes her a spokesperson for freedom, rather than for materialism, tradition, or state control.

The key idea here is that Nick reads Gatsby's death as a total, sweeping destruction rather than a small personal setback. When Nick describes the moment as a holocaust, he's signaling that Gatsby's life, his grand dream, and the social world that supported it are wiped out in one devastating act. The term conveys scale and finality—not just the end of a single life, but the collapse of a complex illusion about reinvention and the American Dream that Gatsby had been pursuing. The word complete reinforces that nothing remains intact—the dream, the identity Gatsby crafted, and the fragile social order around him are all erased in that instant. Other phrasings lean toward a quieter, more intimate sense of loss or shift focus to the setting rather than Gatsby's life. They don't capture the same sense of total collapse and the moral weight Nick senses in the aftermath.

The line targets the moral recklessness and accountability-free mindset of the wealthy. That kind of destructive behavior without responsibility is what makes them a "rotten crowd" in his view. The other traits listed don't capture that specific critique. Staying aloof and silent describes detachment but not the active damage and avoidance of responsibility. Hoarding wealth implies stinginess rather than the destructive, careless conduct Nick condemns. Gossip about others is a social behavior, not the moral collapse and reckless impact Fitzgerald highlights.

Owning or having access to a car also signals wealth, independence, and efficiency, all of which elevate how he is perceived in social and professional circles. In short, the proliferation of automobiles directly enhances Wilson's social value by expanding his opportunities and the impression he can project in a fast-changing society.

He highlights her decisiveness, poise, and ease in navigating social settings, which signals strength rather than timidity. You can trace vanity in her concern with appearances and reputation, independence in her pursuit of her own goals (like her golf career) and her insistence on autonomy, and charm in the way she engages with people and handles situations. Since meekness doesn't fit how Nick portrays her, that is the trait he says she does not possess.

The main idea here is how James Gatz is shown before he becomes Gatsby. A glamorous or ominous temperament doesn't define his early years; neither is he portrayed as fearful or timid. Instead, the focus is on ordinary, earnest growth and the seed of an ambitious future.
