Additionally, independence from feudal ties suggests a positive transformation that may not have been felt uniformly across the rural population, particularly for those who remained vulnerable to the volatility of agricultural production.

The Napoleonic Code ultimately sought to dismantle the remnants of feudalism and replace them with a more modern legal structure, a significant shift from the disorganized state of the law that preceded it.
