Pharmacies in Arkansas are permitted to sell over-the-counter medications and various healthcare products in addition to prescription medications. This allows them to provide a broader range of healthcare solutions for their customers, enabling individuals to manage minor ailments and health concerns with accessible treatments.

Over-the-counter medications include pain relievers, cold and allergy medications, and gastrointestinal treatments, among others. Additionally, healthcare products can encompass items such as first aid supplies, vitamins, supplements, personal care products, and other wellness items. By allowing pharmacies to offer these products, Arkansas ensures that residents have convenient access to essential healthcare items in one location. This stands in contrast to the idea that pharmacies can only sell prescription medications, which would limit their role in the community and impede holistic patient care.
