The role being tested is the Governor-General, who acts as the monarch's representative at the federal level in Australia. This position carries both constitutional responsibilities and ceremonial duties, including giving royal assent to laws, opening Parliament, and swearing in the Prime Minister and ministers, while also representing Australia in various ceremonies and international settings. David Hurley holds this office; he was appointed in 2019 and is a retired Australian Army General. The other people listed do not fit this role: the monarch (King Charles) is the ceremonial Head of State, the Prime Minister (Anthony Albanese) is the head of government, and a state premier ( Roger Cook) governs a state, not the nation.

Budgeting in Australia starts with the government outlining how much money it expects to take in and how it plans to spend it. The Treasury develops revenue forecasts and proposed expenditure, turning policy goals into a detailed plan. The government then presents this budget to Parliament, where MPs and senators debate the proposals and must pass appropriation bills to legally authorize spending for the coming year. Once Parliament approves these bills and they receive royal assent, funds can be spent. This setup means public money is controlled through parliamentary oversight and cannot be spent without the backing of elected representatives, rather than being decided unilaterally by the Treasury or by citizens voting on individual line items.

In Western Australia, the Premier is the head of the state government, chosen as the leader of the political party with the majority in the state parliament. The person who holds this role runs the government, chairs Cabinet, and helps set state policy and laws. Roger Cook is the current Premier of Western Australia, having taken on the role in 2023 after the previous Premier stepped down. He is the state's top political leader and represents the government at the state level, often working with the Governor who formally swears in the Premier. The other names point to different roles: Anthony Albanese is the Prime Minister at the federal level, not the state Premier; King Charles is the monarch (ceremonial figurehead) of the country; David Hurley is the Governor-General at the federal level. These roles sit outside the leadership of Western Australia's state government.

Accountability is the idea that government actions must be explainable, transparent, and subject to review. It means public officials and agencies have to justify their decisions, provide information when asked, and face consequences if they misuse power or fail to meet responsibilities. In Australia, this is supported by mechanisms like parliamentary oversight, independent audits by the Auditor-General, ombudsman investigations, freedom of information laws, and the accountability that comes with elections. While the rule of law ensures actions are made within legal boundaries and democracy or referendums enable participation, the specific concept that ensures actions are answerable is government accountability.

A king or queen ruling under a constitution describes a constitutional monarchy, where the monarch's powers are limited by law and a written constitution. In this setup, real political power typically sits with elected representatives in Parliament and an elected prime minister or equivalent who runs the government, while the monarch's role is largely ceremonial. This contrasts with an absolute monarchy, where the monarch holds substantial governing power; a republic, which has no monarch at all and chooses leaders through elections; and a dictatorship, where power is concentrated in a single ruler or small group often maintained by force and without constitutional constraints. In Australian practice, this means the monarch is the head of state, but Parliament and the Prime Minister govern with constitutional limits in place.

In Parliament, the party that is not governing is known as the Opposition. It is the largest party that doesn't hold the government's formal leadership and seats of power, and its main job is to scrutinise the government, ask tough questions, and present alternative policies. The Opposition often develops a shadow cabinet to mirror the government's ministries, so it's clear who would lead if the government changes. The other terms aren't the same: the Government is the party or coalition currently in power; a Coalition is a formal alliance between two or more parties that forms government; backbenchers are MPs who don't hold ministerial or shadow ministerial roles.

Evaluating government performance relies on active, ongoing participation that goes beyond casting a ballot. The best approach brings together several ways citizens can influence and check how policies are carried out. Voting expresses the overall mandate of the public and can change who holds power. Attending public hearings provides a direct opportunity to hear decision-makers, raise concerns, and see how choices are justified. Tracking policy outcomes means looking at real data to judge whether goals are being met and where programs succeed or fall short. Engaging with representatives creates a channel for feedback, questions, and requests for adjustments. Using media helps inform others, illuminate problems, and mobilize public scrutiny and discussion. When these methods are combined, citizens have a robust set of tools to monitor, critique, and influence government performance. If you only rely on one method, you miss important ways to hold government to account. Voting alone doesn't provide ongoing oversight, while attending hearings, tracking results, engaging with representatives, and using media each offer distinct, complementary forms of accountability.

A constitution is the blueprint that shows how a democracy is run, including who makes laws, how they're made, who enforces them, and what rights people have. In Australia, this framework is the Australian Constitution. It sets up the Parliament, the Prime Minister and Cabinet, the Governor-General, and the High Court; it defines the division of powers between the Commonwealth and the states and outlines how laws are created and checked. It was established when Australia federated in 1901, giving the country its formal system of government. Magna Carta is an ancient document that influenced ideas about limiting rulers, but it isn't the current governing document for Australia. A Bill of Rights refers to a set of specific rights protections in some countries; Australia protects rights through legislation and common law rather than a single national bill. A legal code is a broad term for collections of laws, not the specific constitutional framework that governs how Australia's democracy operates.

Ministers. In Australia's Westminster-style system, a minister is a member of Parliament who leads a government department, sets policy for that area, and is politically responsible for how the department runs. They oversee the department's work, answer to Parliament about its actions, and are part of the executive. Clerks are parliamentary staff, officials are non-political public servants who implement policy under the minister, and MPs are elected representatives who may or may not hold a ministerial portfolio.

Rights that come with being a member of a country are called citizens' rights. Voting is a political right tied to citizenship—you typically must be a citizen to vote in elections. The right to a fair trial is a legal guarantee that applies to people within the legal system as part of the protections you receive as a citizen, ensuring due process and fair treatment in court. These rights define what you can do and what protections you receive as a participant in the country's political and legal life. Civil liberties describe freedoms from government interference (like freedom of speech or religion) rather than the specific package of political and legal rights that come with citizenship. Human rights are universal and apply to all people, regardless of citizenship, though some rights (like voting) are restricted to citizens. Individual rights is a broader, less precise term. So the best label for these particular rights is citizens' rights.
