The tactics learned from the Khobar Towers incident contributed to the planning of the USS Cole attack in 2000, where a similar strategy was employed. An explosives-laden boat was used to approach and detonate alongside the U.S. Navy destroyer, resulting in significant casualties and damage, mirroring the earlier successful tactics at Khobar Towers. This series of events underlined a shift in how terrorist organizations approached targeting military personnel and facilities, emphasizing the evolving strategies in asymmetric warfare. Other options represent significant events but did not have the direct influence on the specific tactics used in the USS Cole attack as seen in the Khobar Towers bombing.
