The key idea is the scope of canon law. Universal law is the set of norms that bind the entire Church worldwide, issued by the competent ecclesiastical authority for all the faithful. In other words, these rules are meant to apply everywhere, across dioceses and rites, not just in one place or community. That's why it's described as universal. Divine law refers to God's eternal moral requirements, which ground obligation but aren't a legislative act of the Church's governing body; human law refers to statutes created by Church authorities, which can be universal or particular but aren't defined by geographic scope alone. Particular law, by contrast, governs a specific diocese or group, not the whole Church. So the term that best describes law applying to the entire Church is universal.

Public associations are groups of the faithful that are officially established by ecclesiastical authority and act in the Church's name, i.e., they have a recognized public juridic status. An example is confraternities or organizations that a bishop officially erects. Such groups have been given canonical standing and authority to operate as representatives of the Church. Private charity clubs, family prayer circles, and volunteer parish catechists are typically informal or privately organized initiatives and do not possess that formal public juridic status unless they are explicitly erected by the competent Church authority.

This openness helps prevent misunderstandings, protects the rights of those involved, and maintains accountability for judges and tribunals within the church system. Secrecy would undermine due process, privately archiving the acts would block oversight and the possibility of review, and publishing only to secular authorities would ignore the canonical framework and procedures that govern church justice.

Laicization is the formal removal of a cleric from the clerical state and a return to lay status under canonical procedures. It ends the cleric's official identity and faculties as ordained, so he may no longer exercise priestly or sacramental powers unless special permission is granted later. This is distinct from a temporary suspension (which is temporary) or excommunication (a penal sanction), and it is not a promotion. The act is a canonical process carried out by the appropriate ecclesiastical authority, and after laicization the person practices as a layman within the Church's rules.

In canon law proceedings, the acts of the process—including decisions, orders, and procedural steps—are released through the official ecclesiastical channels to the parties involved. This ensures due process: the parties receive timely, formal notification, have the opportunity to respond, and understand the grounds and timeline of the proceedings. It also creates an authoritative record within the Church's proper offices for accountability and potential review. Publishing only within a judge's chamber would deprive the parties and oversight bodies of access, undermining transparency. Limiting publication to the diocese would narrow the scope of record-keeping and public accountability, whereas the formal acts belong in the Church's official record and channels beyond a single local sphere. Publishing on secular government websites is not appropriate, since canon law matters fall under ecclesiastical jurisdiction and require publication within the Church's own systems to preserve confidentiality, proper process, and avenues for canonical appeal.

When lay faithful work officially for the Church, they have the right to just compensation for their labor. This reflects the Church's commitment to the dignity of work and to treating employees fairly, in line with both civil labor norms and canon law. It applies to lay staff, administrators, teachers, and other lay collaborators who serve in dioceses, parishes, or religious institutions. This right does not imply any guarantee of priestly ordination or automatic clerical elevation, nor does it confer immunity from civil laws. Those outcomes depend on separate calls, processes, and legal rules. The specific terms—salary, benefits, and conditions—are shaped by employment contracts and applicable civil law, but the core idea is fair, just compensation for the services rendered.

Lay faithful, on the other hand, are baptized Catholics who have not received Holy Orders and are not members of institutes of consecrated life with solemn vows. This means the lay faithful are the baptized who are not ordained and not in solemn religious vows, while those who live a consecrated life (even with vows) are not counted among the lay faithful.

The Pope is the source of universal canon law, wielding the supreme, universal ordinary power to legislate for the whole Church. He can enact and promulgate canon law through formal acts such as an apostolic constitution, with the Holy See and the Roman Curia assisting in drafting, advising, and implementing those laws. The College of Bishops participates in governance and can shape shepherding decisions, but it does not independently issue universal canon law. The Congregation for the Doctrine of the Faith handles doctrinal and moral matters and issues guidelines related to faith, not the universal legislative code of the Church. So the ultimate authority to enact universal canon law rests with the Pope, supported by the Holy See and the Curia.

In private international/private law contexts, the place where the wrong occurred is the locus delicti. This location is used to decide which tribunal has jurisdiction and which law applies to the delict, because it anchors the case to a specific forum and a governing set of rules. In canon law and related jurisdictional practice, determining the delict's locus helps align the correct ecclesiastical court and the applicable statute of limitations, penalties, and substantive law, often via the principle of *lex loci delicti commissi*—the law of the place of the delict. Other terms don't capture this concept. Locus actus refers to the place where the act took place, which is not the established basis for jurisdiction and applicable law in delict matters. Locus loci actus is not a standard term. Locus ecclesiae denotes the place of the church or its seat, not the delict's location for purposes of forum and choice of law.

Excardination is the act by which a cleric is released from the incardination he has in a diocese or religious institute so that he can be attached to another jurisdiction. In practical terms, a cleric's canonical bond is to the church authority that incardinated him; excardination ends that bond and transfers him to the jurisdiction of another diocese or institute. This is different from simply being attached to a see or institute, which describes incardination itself. It's not a temporary transfer, which would leave the cleric still under the original incardination. And laicization is a separate process where a cleric leaves the clerical state entirely. So the definition that fits is the cleric being released from one diocese or institute in order to join another.
