Voting rights cannot be denied because of race. This protection comes from the Fifteenth Amendment, ratified in 1870, which states that the right of citizens to vote shall not be denied or abridged on account of race, color, or previous condition of servitude. It was enacted during Reconstruction to secure Black men's right to vote after the Civil War. Although it established the guarantee, many states found ways around it for decades, leading to later reforms like the Voting Rights Act of 1965 that strengthened enforcement. Other amendments address different issues: one prohibits denying the vote based on sex, another bans poll taxes in federal elections, and another lowers the voting age to 18.

The formal name for the first ten amendments is the Bill of Rights. Common good is a broader political idea, not the label for this group of amendments. So the Bill of Rights is the correct name for the first ten amendments.

The main idea here is the length of time you must be a lawful permanent resident before applying for naturalization. The standard path requires five years of permanent resident status. This period shows you've established ties to the United States and met the basic residency and stability expectations that demonstrate your commitment to the country, along with other required qualifications like being at least 18, having good moral character, and knowledge of U.S. history and civics. There are exceptions—for example, if you're married to a U.S. citizen, you can apply after three years—but for the typical route, five years is the standard duration.

Poll taxes were a barrier to voting tied to a person's ability to pay. The other amendments address different aspects of who can vote—age, gender, or race—without specifically banning poll taxes in federal elections.

Civic responsibility is the voluntary duty to participate in public life and support the community's welfare. The common good is the outcome our collective efforts aim for, not the personal obligation itself. Obligation is a broad term for a duty, which can be legal or moral, but it doesn't specifically capture the voluntary, active participation that civic responsibility describes. Selective service is a legal requirement, so it isn't the right fit for describing a voluntary civic duty.

Habeas corpus is the protection against being held without charges by requiring a court to review the lawfulness of detention. It ensures that if someone is jailed, the government must justify the restraint and bring them before a judge, so detention isn't endless or arbitrary. This check on executive power helps guarantee due process and personal liberty. A writ is a type of court order, and one specific writ related to detention is used to seek release, but the fundamental safeguard is habeas corpus itself. A draftee refers to someone called to military service, and civil disobedience is the act of protesting by disobeying laws—neither directly protects detention rights.

The other options point to a single amendment (not the whole document), a principle about fair legal procedures, or a civic idea, none of which describe the document itself. So the correct term for the document containing these civil liberties is the Bill of Rights.

The goal is to prevent barbaric methods and ensure a fair, humane approach to sentencing. Choices that talk about free-speech protections, conscription, or general guarantees of equal protection don't address how punishment is limited or rated in severity, which is why they don't fit this concept.

Prosecute means to bring a legal action against someone who is accused of a crime in order to prove guilt in court. In criminal cases, the government, through a prosecutor or district attorney, files charges and presents evidence at trial to establish guilt beyond a reasonable doubt. This action is specific to pursuing a criminal case. Segregation is about separating people, not initiating a case. The rights of the accused refer to protections during the process, not the act of filing charges. Marbury v. Madison deals with judicial review and the power of courts to interpret laws, not with prosecuting someone.

Naturalization is the formal legal process by which an immigrant becomes a citizen.
