Hence, "Write" is the most precise term for the act of producing characters or symbols on a surface.

Each of these terms serves a different context and does not relate specifically to the unfair treatment fueled by prejudice.

The notion of being righteous can sometimes overlap with the concept of a strong moral compass; however, it often implies a self-righteousness that could be more judgmental rather than grounded in compassion and conscientious thought. Thus, the best fit among the options for someone with a strong moral compass is the description of being conscientious.
