Capturing timely news images hinges on covering events as they unfold and delivering stills quickly for distribution by news outlets. The professional who specializes in this is the photojournalist. They focus on current events, tell stories through images, work under tight deadlines, and often provide captions and context for agencies like AP or Reuters. A general photographer might work across many genres, but not specifically on deadline-driven news coverage. Editors curate and refine images after capture, while retouchers adjust images post-production. So the role that best fits the task of capturing timely news images for agencies is the photojournalist.

The main idea is parallax between the viewfinder path and the sensor in rangefinder cameras. Because the eyepiece looks through an optical path that is offset from the lens axis, what you see in the viewfinder is not exactly the same image the sensor records. This difference becomes noticeable at close distances, where even a small angular offset translates into a visible shift in composition or framing. So what you frame or focus through the eyepiece can differ from what the sensor captures in the final image, especially on close-ups. That's why that statement is true. At longer distances, the parallax effect is much smaller, which is why the issue is most evident up close. Some cameras offer parallax-correcting framelines or rely on live view to check the sensor view, but the basic discrepancy remains a characteristic disadvantage of rangefinder viewing.

In catalog photography, a clear, scalable system for naming and organizing files is essential because you're often juggling thousands of assets across many shoots. The best approach uses a consistent file naming scheme that encodes key details for quick identification—something like `project_date_client_product_revision`. This means each file carries its own context: which project it belongs to, when it was shot, who the client is, what product appears, and which revision it represents. That self-describing name makes searching, sorting, and cross-referencing assets fast and reliable, even after years of work. Pair that with a structured folder hierarchy that keeps different stages separate—RAW for untouched captures, PROOFS for proofs or previews, and FINAL for approved deliverables. Keeping these stages in distinct folders prevents mixing files at different processing levels and helps protect the integrity of the final deliverables. Adding metadata (keywords, shoot date, client, product, location, equipment) makes assets even more searchable in a digital asset management system, so you can find exactly what you need without opening dozens of folders. Tracking version history gives you visibility into what changed between revisions and lets you revert if a decision gets overturned. Finally, maintaining offsite backups guards against data loss from hardware failure or emergencies, which is crucial for large catalogs. In contrast, inconsistent naming and random folders create confusion, slow down collaboration, and raise the risk of misfiling or losing assets. Storing everything in a single folder without backups makes retrieval inefficient and endangers the archive. Renaming files only per client contract fragments the naming system and undermines the ability to trace assets across projects.

Buzz Aldrin also walked on the Moon that same mission, but he followed Armstrong, so the strongest answer for the notable 1969 event is Armstrong's first Moonwalk. The other events happened earlier: John Glenn orbited the Earth in 1962, and Yuri Gagarin became the first person in space in 1961.

For photographs, you want a format that reduces file size while keeping viewing quality acceptable. JPEG fits that need by using lossy compression that removes image data the human eye is less likely to notice. This approach dramatically drops file sizes compared to lossless formats, making it ideal for web use, sharing, and storage. JPEG's balance of decent image fidelity, small file sizes, and broad support across cameras, apps, and devices is why it became the standard for compressing image data and remains the most common choice. It handles full color depth (24-bit) and offers adjustable quality so you can tune how much detail you're willing to trade for smaller files. By contrast, formats like PNG are lossless and excel with sharp edges or transparency but produce larger files for photos; TIFF is geared toward high-end printing and archival use; BMP is largely outdated and inefficient for modern web use.

To stop action, you freeze motion by shortening the exposure time. A faster shutter speed reduces the amount of time the sensor is collecting light, so moving subjects blur less or not at all, giving a crisp image. The exact speed you need depends on how fast the subject is and how close you are, but the principle holds: quicker shutter equals less motion blur. Other tools can help in different ways—opening the aperture or raising ISO can compensate for light so you can use a faster shutter, but they don't directly stop motion by themselves. A tripod reduces camera shake, not subject movement.

Tethered shooting is about connecting the camera to a computer so images appear live on a screen as you shoot. This setup lets you evaluate focus, exposure, lighting, and composition in real time, and it often includes client previews during the session to speed up decisions. The file management practices listed—consistent file naming, an organized folder structure, automatic backups, real-time client previews, and cataloging—fit this workflow perfectly. Consistent naming (for example, date, client, sequence) prevents duplicates and confusion as shoots generate many files. An organized folder structure keeps everything grouped by project and date, making it easy to locate assets later. Automatic backups protect against data loss by saving copies to a separate drive or cloud. Real-time client previews integrate into the session so clients can approve or adjust on the spot, keeping the shoot efficient. Cataloging, through metadata or a digital asset management system, helps you tag and search images later for quick retrieval and reuse. The other descriptions don't reflect the live-screen workflow and the practical file-handling discipline that tethered shooting relies on.

Key-to-fill ratio in three-point lighting describes how much brighter the key light is compared to the fill light. A 2:1 ratio means the key is twice as bright as the fill. In practical terms, the fill provides about half as much illumination as the key, so shadows are present but softened rather than completely erased. This yields a natural-looking contrast between light and shadow. The backlight (rim light) is a separate element that affects separation from the background, not the key-to-fill relationship. So the interpretation is that the key is twice as bright as the fill.

Polarizing filters block light waves vibrating in specific directions, which reduces reflections from shiny surfaces. When light reflects off a glossy area, it becomes polarized and creates glare that washes out detail and dulls color. Rotating the filter to align with that polarization blocks much of the reflected light, so glare decreases, surface details appear, and colors look more saturated. The other options don't capture this effect: polarizers don't speed up exposure, don't primarily change background color, and any perceived sharpness comes from reducing glare rather than actual optical sharpening.

In manual exposure, you control how much light the camera sensor records with three settings: shutter speed, aperture, and ISO. Shutter speed governs how long the sensor is exposed to light—faster speeds freeze motion but let in less light, slower speeds gather more light but can blur movement. Aperture is the lens opening—a wider aperture (lower f-number) lets in more light and creates shallower depth of field, while a smaller aperture (higher f-number) lets in less light and increases depth of field. ISO measures the sensor's sensitivity to light—lower ISO gives cleaner images but requires more light, higher ISO allows shooting in darker conditions but adds noise. These three interact to determine the overall exposure, and in manual mode you set all three to achieve the desired brightness and look. The other options aren't part of the exposure controls: white balance affects color rendering, not brightness; focal length changes framing and perspective; color space and color temperature relate to color management and white balance rather than the amount of light captured.
