In contrast, guessing randomly on all remaining questions would not be efficient, as it does not leverage any partial knowledge you may have. Focusing solely on unanswered questions ignores any previously attempted questions that may still require revision or reassessment. Trying to finish every question with detailed answers can consume too much time, potentially resulting in unanswered questions, which can directly impact your overall score.
