D: 'Specific' outcomes should be based on evidence, but this alone does not fulfill the criteria of a SMART outcome. Specificity also takes into account the details and context of the outcome.

The other options, such as observational, indirect, and passive, all suggest a more hands-off or distant approach to safety management, which may not be as effective in promoting and maintaining a safe working environment.
