Any firearms safety or training course available to the public is considered acceptable for demonstrating competency with a firearm for the Florida CWFL. This includes courses taught by NRA-certified instructors, as well as other courses available to the general public. Military training is not the only acceptable form of training, and self-taught firearm safety may not provide the necessary knowledge and skills needed to safely handle and use a firearm.
