Therefore, while population geography is an important field of study, it is not categorized as one of the main branches of geography, which supports the choice made.

Price elasticity refers to the responsiveness of quantity demanded or supplied to changes in price, opportunity cost involves the benefits that are foregone by choosing one alternative over another, and comparative advantage relates to the ability of a party to produce a good or service at a lower opportunity cost than others.

Each of these efforts worked towards ensuring not only immediate support but also the long-term stability and growth of the U.S. economy. This multifaceted approach is what defined the New Deal and made it a significant governmental response to one of the most challenging economic times in American history.

This collision gave rise to the highest peaks in the world, including Mount Everest, located in Nepal. In this context, while China and India both have large segments of the range, Nepal is home to some of the most famous peaks and is crucial to the Himalayas' geography. The other options are not correct either because they exclude important countries or include regions that do not contain parts of the Himalayas. Specifically, Bangladesh, while in proximity, does not feature the mountain range within its borders.
