Height is closely linked to the lengths of the long bones in the limbs, and Mildred Trotter built her stature-estimation method on that solid, predictable pattern. The method uses measurements of the long bones—primarily the femur, tibia, and humerus, with possible additions like the radius and ulna—to derive regression equations that predict living stature. These bones provide the strongest, most consistent relationship with overall height and they tend to preserve well in skeletal remains, making them the most reliable basis for estimating stature in forensic cases. Teeth aren't reliable predictors of height, since their size and wear don't track a person's total stature. Pelvic bones are crucial for determining sex and can offer limited ancillary information about stature, but they aren't the basis of Trotter's stature equations. Skull length varies for reasons unrelated to height and doesn't correlate as robustly with overall stature as long-bone lengths do.

This commitment shapes how remains are handled, documented, and interpreted, and it informs communication with families, communities, and legal authorities. It means treating remains with dignity, considering cultural and religious beliefs, and upholding standards of consent, confidentiality, and proper repatriation when relevant. When this respect guides practice, the work remains accountable, accurate, and professional. Shortcuts that prioritize speed over accuracy, spreading gossip, or sensationalizing findings undermine trust, harm those connected to the deceased, and violate professional obligations.

Aging signs on the auricular surface come from cumulative remodeling of the sacroiliac joint as bone responds to years of load and wear. With age, the surface becomes more irregular and develops textural changes such as rugosity and porosity, and the bone can take on a darker appearance due to ongoing remodeling and deposition. This combination—an irregular, rough surface paired with a darker color—best reflects advanced aging of the auricular surface. In contrast, younger individuals tend to have a smoother, lighter-colored surface, so describing older age with a smooth, dense, or pale surface wouldn't fit aging changes.

A value of zero in these genetic diversity statistics signals no detectable differentiation between populations. In measures like F_{ST} or genetic distance, zero means the allele frequencies are effectively identical across the populations for the loci examined, so there's no genetic structure distinguishing them. This doesn't mean there is no genetic variation within a population; it means the variation observed is not partitioned into between-population differences. Higher values indicate increasing differentiation, with larger numbers showing populations becoming more genetically distinct. So, zero best reflects that the populations are the same in the scope of the measured markers.

Postmortem data refers to information collected after death. Medical History Review centers on gathering and interpreting the deceased's medical records to identify pre-existing conditions or treatments that may have contributed to death. This means looking at prior diagnoses, chronic illnesses, medications (including dosages and potential interactions), recent hospitalizations or surgeries, allergies, and any recent symptoms or events that could relate to the death. By understanding the person's health background, investigators can contextualize findings from the autopsy, assess possible contributing factors such as drug toxicity or untreated conditions, and help distinguish immediate causes from contributing factors. This distinguishes it from examining tissues and organs (which is the autopsy itself), from packaging and transporting evidence (a different, chain-of-custody task), and from the collaborative processes involved in a death investigation (teamwork is part of the broader process but not the definition of medical history review).

Gender refers to social and cultural roles, behaviors, expectations, and identities connected to being male, female, or other; it also includes how someone experiences and expresses themselves. A person's gender identity may match the sex they were assigned at birth or may differ, and gender can vary across cultures and over time. The correct statement captures this separation: biology defines sex, while social and personal identity define gender. The other options mix up these distinctions or treat sex and gender as interchangeable, which isn't accurate.

Clavicle aging is about when the clavicle's growth ends, which is tied to the fusion of its epiphyses. The last epiphysis to fuse serves as the best marker for age, because before fusion the bone shows growth plates or fusion lines, while after complete fusion there are no fusion lines or fragments remaining. In practice, you assess whether the medial or lateral clavicle epiphysis has fused; if fusion lines or unfused areas are still visible, the individual is younger, whereas complete fusion with no lines indicates an older age. This is why the statement that it relies on the timing of the last epiphysis fusion and looks for absence of flakes or fusion lines best captures the method. It is an age-estimation approach that is not based on rib end morphology.

Random match probability is the estimated chance that a given genetic match could occur by random chance in the population. It uses allele frequency data from reference populations and the observed profile to produce a numeric value. This number helps describe how strong a match is: a very small probability means it's unlikely that the same profile would appear by coincidence, so the identification carries greater evidential weight. Conversely, a higher probability signals that the match could plausibly arise by chance, weakening the strength of the identification. It does not guarantee certainty, it does not measure time since death, and it does not replace DNA analysis. Instead, it provides a quantitative measure of how likely the observed match is to be coincidental, guiding how confidently the identification should be presented.

A younger pubic symphysis is best characterized by a textured articular surface with many ridges and furrows. This rugose texture reflects ongoing growth and remodeling of the joint as the pelvis matures. As individuals age, the surface tends to smooth out and can become eroded due to degenerative changes, and a completely fused joint is not typical of the adult pubic symphysis. So, the presence of numerous ridges and furrows indicates a younger stage of the joint's development.
