Option C, Only for law enforcement and military, is incorrect as civilians are also allowed to own and use suppressors. Option D, Only with a special permit, is incorrect as no special permit is required for civilian ownership and use of suppressors in Iowa.

10. What is Iowa's stance on the open carry of firearms?
