The Commander in Chief of the military is the President of the United States. This role is established in the U.S. Constitution, specifically in Article II, Section 2, which gives the President the authority to command the armed forces. Since then, an additional seventeen amendments have been ratified, the most recent being the twenty-seventh amendment, which was ratified in 1992. This amendment limits congressional pay increases until after the next election. It's important to note that while there have been proposals for amendments, only twenty-seven have successfully gone through the rigorous process of ratification and have become part of the Constitution.

Conversely, the judiciary can review laws and executive actions to determine their constitutionality. This interplay of authority is designed to prevent the concentration of power, thereby protecting democratic governance and individual liberties. In contrast, judicial review refers specifically to the judiciary's ability to interpret laws and assess their alignment with the Constitution and does not encompass the entire system of checks and balances. Direct democracy focuses on citizens voting directly on laws rather than through representatives, which does not pertain directly to balancing powers among branches. Constitutional amendments pertain to changing the Constitution itself and do not directly prevent power consolidation among the branches of government.
