A red traffic light indicates that vehicles must come to a complete stop and are not permitted to proceed through the intersection. In contrast, other options such as a warning and admonishment or community service alone do not sufficiently address the seriousness of DUI offenses, especially considering their potential consequences. Additionally, the notion that there are no penalties for DUI is inaccurate, as it overlooks the legal ramifications that are crucial for promoting road safety.

The '↖' sign indicates an unprotected left turn. These triangles are typically placed at appropriate distances behind the vehicle to provide adequate warning and are a standard safety requirement enforced by driving regulations. While GPS navigation, extra fuel storage, and all-terrain tires can be beneficial or even necessary in specific circumstances, they are not universally required equipment for the safe operation of commercial vehicles. Therefore, having reflective triangles is a critical safety measure mandated for all commercial drivers to ensure their safety and the safety of others on the road.
