The numerical designation denoting house addresses to the north in Chicago is 6400 North. Chicago's addressing system is grid-based, allowing for a systematic way to identify locations throughout the city. The numerical designations are based on distance from State Street in the central part of the city. In this system, addresses increase as you move further north from the baseline (which is often considered the zero point), resulting in higher numbers assigned to locations further away from the downtown area.
