1. Which readiness condition is used to ensure continuity of mission-essential functions in a cyber-contested environment?

A. IAVA

B. CPCON

CPCON, or Cyber Protection Condition, is the readiness status used to ensure continuity of mission-essential functions in a cyber-contested environment. It provides a framework for adjusting the cyber defense posture to protect critical operations, guiding actions like heightened monitoring, system hardening, patch management, rapid incident response, and recovery planning. In a cyber threat scenario, CPCON levels indicate when to increase defenses and implement higher readiness to keep essential functions operating despite adversarial activity. IAVA relates to vulnerability alerts that push for applying patches, but it isn't a readiness condition for sustaining operations. FPCON concerns physical security measures rather than cyber resilience. Therefore CPCON best fits the requirement of maintaining mission-critical functions under cyber disruption.

2. What are the three basic structures for multinational operations?

Multinational operations can be organized under three principal command structures to balance unity of effort with political and legal constraints. The first is integrated command, where forces from different nations are placed under a single multinational commander and share a common command and control system, doctrine, and logistics; this yields seamless coordination and rapid decision-making. The second is the lead nation concept, in which one nation assumes the overall command responsibility for the operation and directs participating national forces under an agreed framework, while other nations contribute forces and sustainment as partners; this preserves national sovereignty while providing clear direction. The third is parallel command, where each nation retains its own national command, but there is coordination at the international level through liaison and a coordinating mechanism; this allows coalition work when political or legal constraints prevent combining under one command, though it demands strong liaison to avoid mutual interference. Hence, this trio—integrated, lead nation, and parallel command—covers the spectrum of multinational command options. Other options mix terms that describe coalition composition or different alliance concepts but do not represent the three basic command structures.

Operational intelligence at the operational level combines understanding what the enemy can do and what they intend to do with how we plan and execute campaigns. It includes focusing on the enemy's military capabilities and intentions, which informs risk assessment, course-of-action development, and decision-making about where and how to act. It also involves identifying the adversary's centers of gravity and critical vulnerabilities, so we can pinpoint decisive points to influence the fight and exploit weaknesses effectively. Finally, it supports the planning and conduct of joint campaigns and operations by providing timely, relevant intelligence that shapes force deployment, sequencing, and coordination among partners. Put together, these elements describe how operational intelligence guides the entire campaign from discovery to execution.

4. Which term best describes the capability to move and maneuver to secure positional advantages?

The main idea here is the ability to move and maneuver to seize or hold advantageous positions. This capability is described by Operational Movement and Maneuver, which covers how forces physically reposition, exploit terrain, and adjust tempo to gain a positional edge and shape how the battle unfolds. Sustainment focuses on keeping forces supplied and able to sustain operations, rather than the act of moving to a better position. Operational Reach deals with how far and fast a force can project power and stay effective at distance, not the act of maneuvering itself. Scheme of Fires is about the planning and coordination of fires to support operations, not the movement of forces to secure the high ground or flanking positions. So, the term that best describes moving and maneuvering to secure positional advantages is Operational Movement and Maneuver.

5. Which term describes the outcome that results from task execution or linked tasks?

Focus here is on what you observe as the result after performing actions. The outcome produced by task execution or by a chain of linked tasks is the effect—the impact or end state created by those actions. A mission is the overall purpose behind the operation, not the immediate result. An objective is a specific, measurable target you aim to achieve, and a constraint is a limiting factor that restricts what you can do. For example, after completing a sequence of maintenance actions, the effect would be the ship's readiness restored, which is the real impact of those tasks.

6. Which Planning Horizon is normally associated with Future Operations that focuses on the 'what If' (from approximately 96 hours out to 60 days)?

Planning horizons shape how far ahead you think and how much detail you apply. For Future Operations that focus on “what if,” the appropriate window is the mid-term, which spans roughly 96 hours out to 60 days. This horizon lets you explore contingency scenarios and adjust plans for manpower, equipment, maintenance, and logistics in a realistic but not immediate timeframe. It's long enough to see the consequences of different actions and short enough to implement without excessive lead times. Near-term would be too immediate for meaningful contingency adjustments, while far-term extends beyond 60 days and tends to be more strategic in nature.

7. In NEO planning, designated persons include which groups?

In NEO planning, you must identify everyone who might need evacuation or assistance, not just one nationality or role. Designated persons are identified broadly to cover local staff and foreign nationals living in the area, plus those the plan designates for evacuation regardless of nationality. This means including host nation employees, third country nationals, and designated persons such as US citizens. It ensures the plan can account for all groups that might require evacuation, rather than narrowing to a single category. The other options are too limited: focusing only on host nation employees omits foreign nationals; focusing only on US citizens omits local staff and other nationals; and focusing on DoD contractors excludes the broader groups typically encompassed in designated-person planning.

8. Which statement about the end states measured by Operation Assessment is NOT a possible end state?

End states measured by Operation Assessment are the tangible effects the operation produces—the concrete changes or completions that show progress toward the intended aim. An end state describes something new that exists or has been accomplished: the objective is reached, a specific task is completed, or a condition in the environment is created. Keeping things exactly as they were, with no change, does not reflect any produced effect or outcome. It doesn't demonstrate progress or a fulfilled objective, so it isn't considered a valid end state. The others—meeting an objective, finishing a task, or creating a new condition—all represent clear, measurable results of the operation.

A Navy headquarters handles three essential tasks: building and maintaining readiness (preparing the force), supplying the required resources and personnel (providing the force), and directing and executing operations (employing the force). Preparation covers training, doctrine, and readiness oversight so units can perform when called upon. Providing the force means allocating and delivering ships, aircraft, people, and logistics to meet mission needs. Employing the force involves planning, issuing orders, and leading forces in operations. Because a HQ is responsible for all three areas, it fulfills each function, making "All of the above" the best answer.

10. Which term is defined as the physical or behavioral state of a system that results from a action, a set of actions, or another effect?

A. MOE

B. MOP

C. Task

D. Effect

The idea being tested is how we name the state a system ends up in after something acts on it. An effect is the physical or behavioral state that results from an action (or a set of actions) or from another effect. In other words, it's the consequence you can observe in the system after you apply something. For example, applying throttle to a vessel changes its speed and possibly its heading—that change in speed or direction is the effect. MOE refers to Measures of Effectiveness, which are about mission-level impact and whether goals are achieved, not the immediate state of the system. MOP stands for Measures of Performance, which quantify how well a capability functions (attributes like speed, range, accuracy, etc.) rather than describing the final state itself. A task is simply a unit of work to be performed, not the resulting state.
