1. Which term describes the act of leaving the Union, such as what South Carolina did after the Lincoln election?

- A. Withdrawal**

Secession is the formal act of withdrawing from a larger political union. After Lincoln's election, South Carolina explicitly moved to leave the United States, which is exactly what secession describes. Withdrawal is a more general term for leaving and lacks the formal, political step involved. Cession means giving up territory to another power, typically through agreement or treaty, not leaving a union. Separation is a broad idea of parting ways and doesn't specify the act of leaving the union itself. So, the term that best fits is secession.

2. Which battle is described as the turning point of the war, ending with a Union victory?

A turning point in a war is a moment when the balance of power shifts in a lasting way, changing the direction of the conflict. Gettysburg fits this idea because, in early July 1863, a large Confederate invasion into Union territory was halted after three days of intense fighting. The Union victory stopped Lee's campaign on northern soil and inflicted heavy losses, shifting the momentum firmly in favor of the North. The impact is strengthened by the nearby Union victory at Vicksburg, which gave the Union control of the Mississippi and effectively split the Confederacy. After Gettysburg, Confederate offensives became less viable and the Union maintained the strategic initiative for the rest of the war, making a Union victory more likely. For context, Fort Sumter is the war's start, not its turning point. Antietam was a significant clash that checked a Confederate invasion and influenced political actions, but it did not end the war. Appomattox Court House is where the war concluded, not where momentum shifted.

3. Which president led the United States through the Civil War and supported the passage of the 13th Amendment?

The key idea is identifying the president who both led the country through the Civil War and backed ending slavery through a constitutional change. Abraham Lincoln fits both parts: he was the president during the Civil War and he strongly supported making slavery illegal nationwide by pushing the 13th Amendment. That amendment, ratified in 1865, forever abolishes slavery in the United States. The other names played different roles or were in office at different times, so they don't match both parts of the question.

4. Which agreement marked the end of Reconstruction after the Civil War?

- A. Emancipation Proclamation**

- D. Reconstruction Act of 1867**

The main idea here is identifying what political development marked the end of Reconstruction. The end came with a deal that settled the disputed 1876 presidential election and led to removing federal troops from the South, allowing Southern states to return to self-rule and roll back protections for newly freed Black citizens. That agreement is the Compromise of 1877. Because it effectively finished the federal efforts to reshape Southern society during Reconstruction, it stands as the moment Reconstruction ended. Understand the other options in context: the Emancipation Proclamation freed enslaved people in Confederate-held areas during the war but did not determine how Reconstruction would be carried out or end; the Gettysburg Address, though important for shaping national purpose, was a wartime speech, not a postwar political settlement; the Reconstruction Act of 1867 launched and structured the Reconstruction process by organizing Southern states and requiring new constitutions and amendments, but it did not mark its end.

Acts of defiance by enslaved people—escaping, rebelling, burning crops, breaking tools—fall under the idea of resistance. Resistance is the broad term historians use for efforts to oppose slavery and seek freedom, whether through daily acts that hinder the system or through more organized uprisings. The other terms describe narrower or different things: rebellion usually refers to organized uprisings against slaveholders, abolitionism is the movement to end slavery, and unionism in this context would refer to loyalty to a political entity or to labor unions, not the acts of enslaved people themselves. Therefore, resistance best captures the full range of actions described.

6. Where did General Lee surrender to General Grant, effectively ending the war?

The end of the Civil War comes with a formal surrender that signals that major fighting has ceased. The location where that surrender took place carries symbolic and practical significance. General Robert E. Lee surrendered his Army of Northern Virginia to General Ulysses S. Grant at Appomattox Court House in Virginia on April 9, 1865. This act effectively ended the war, with terms that allowed Confederate soldiers to go home and return to civilian life. Fort Sumter is where the war began, not ended. Gettysburg was a crucial turning point in the war, but fighting continued after that battle. Richmond was the Confederate capital, but the decisive surrender occurred near Appomattox Court House.

7. Which campaign involved Sherman marching through Georgia to destroy resources for the Confederate war effort?

This question tests recognizing a Civil War campaign famous for a bold march through Georgia aimed at crippling the Confederacy by destroying its resources and logistics. That campaign is Sherman's March to the Sea, led by William T. Sherman after the fall of Atlanta in 1864. The army moved from Atlanta to Savannah, employing scorched-earth tactics—burning and destroying railways, warehouses, factories, and other supply sources—so the South couldn't sustain its war effort and morale declined. The other campaigns happened in different places or with different goals: the Vicksburg Campaign focused on gaining control of the Mississippi River, not Georgia; the Peninsula Campaign attempted to take Richmond by advancing up the Virginia Peninsula; and the Wilderness Campaign was part of Grant's operations in Virginia. Thus, the march through Georgia to destroy Confederate resources best fits Sherman's March.

8. Which meeting led to drafting a new Constitution to replace the Articles of Confederation?

The meeting that produced a new framework to replace the Articles of Confederation is the Constitutional Convention, held in Philadelphia in 1787. Delegates gathered to revise the Articles, but they ended up drafting a new document—the United States Constitution—that created a stronger central government with three branches and checks and balances. The Philadelphia Convention is another name for the same gathering, so it's often referred to by both terms. Earlier meetings, like the First Continental Congress and the Second Continental Congress, occurred before and during the Revolutionary War and did not replace the Articles with a new constitution.

9. Which policy established a framework for admitting new territories from the Northwest to statehood?

The policy being tested is a plan that creates an orderly path for turning new lands into states. The Northwest Ordinance did this for the Northwest Territory, providing a clear sequence from governance to statehood. It started with a territorial government led by a governor, secretary, and judges. As the territory grew and reached about 5,000 free adults, residents could elect a territorial legislature. When the population reached roughly 60,000 free inhabitants, the people could draft a constitution and petition for admission as a state with equal status to the original states. The Ordinance also laid down rights for settlers, including religious liberty and trial by jury, and it prohibited slavery in the territory, signaling how new states would be brought in on a basis of standardized governance and rights. This framework differs from other items that dealt with different issues: for example, one document was about seeking reconciliation with Britain during the Revolution, another arranged land surveys and sales, and another ended the war with Britain and recognized independence.

John Adams fits this description because he was a driving advocate for independence in the Continental Congress, helping push the colonies to break from Britain. He then served as the United States' first Vice President under George Washington and later became the second President. The Alien and Sedition Acts came from his presidency, a set of laws aimed at strengthening national security and restricting dissent during a time of international tension. These acts are a defining part of his time in office, even though they are controversial for limiting civil liberties. Washington was the first President and did not spearhead these acts; Jefferson was a strong advocate for independence and the author of the Declaration, but he was the third President and not associated with these laws; Madison contributed to the Constitution and political development but is not linked to the Alien and Sedition Acts.
