## 1. What action is required if a Michigan CPL holder changes their address?

If a Michigan CPL holder changes their address, they are required to notify the issuing county clerk within 10 days. This is because CPL holders are required to keep their information up-to-date and failure to do so could result in penalties. Option B is incorrect because it is necessary to notify someone.
