A signing bonus is typically a one-time payment awarded to a player upon signing their contract, often used as an incentive to attract the player to a team. The other options, while they may contain elements of truth in different contexts, do not address the specific requirement related to the 30% increase that governs player contracts in this situation. Contracts renegotiated in uncapped years can still face scrutiny and limitations based on financial best practices, meaning that the

This process is designed to protect teams from losing players for nothing, as they have the ability to claim a player who may still have value to other franchises. If multiple teams place a claim on the player, the team with the highest priority in the waiver order will secure the player. Only if no team claims the player during the waiver period does he become a free agent and can sign with any team, thereby having the opportunity to negotiate new terms. The other options do not accurately represent how waivers work — for instance, a player cannot immediately join any team after being released. Thus, the nature of waivers and the claiming process directly supports the assertion that the player can only sign with the team that claims him.

If the original team does not match the offer, they do not receive any compensatory draft picks in return, contrasting with other tender options, such as the Franchise Tag. This system aims to balance the interests of both the player and the teams, ensuring that players receive fair market value based on their peers' salaries while still offering teams some level of control over their roster. Other options do not accurately describe the Transition Tender's purpose: the guaranteed contract over four years is unrelated, the 5th-year option pertains to rookie contracts, and the Franchise Tag specifically applies to players deemed elite, allowing teams to retain key talent at a higher salary threshold.

This participation can include being on injured reserve (IR) as well. Hence, the definition of a credited season depends on a player's actual presence in the weekly roster situation rather than just being part of the league or any game played in a season. A choice indicating three games does not align with the requirements set forth by the NFL collective bargaining agreements, as it falls short of the threshold necessary to count for a credited season.
