Sometimes, this alone can deter anti-social or criminal behavior. The second stage is 'Verbal Communication.' Here, the security officer uses dialogue to gain compliance. This could be simply advising, questioning, or issuing a directive to the suspect. The third stage is 'Physical Control.' If a suspect does not comply with the verbal communication, the security officer might have to use physical measures to gain control. This could be in the form of simple restraint methods or bodily force. The fourth level is 'Intermediate Weapons.' These are non-lethal weapons used to restrain a suspect, such as batons and pepper spray, which do not typically cause permanent harm. The final stage is 'Lethal Force.' This is the highest level of force and is only used when all other options have been exhausted or when the threat of death or serious bodily harm exists. It could involve using firearms or

This includes the necessary forms and instructions on how to obtain a security license. So, both of these options are valid ways to obtain the required information.
