Additionally, while Muhammad was a leader in a time of conflict, the promotional aspect of military conquest does not capture the essence of Islamic teachings, which primarily focuses on spiritual, moral, and social guidelines rather than militaristic ambitions.

This event directly connected the Franco-Prussian War to the broader process of German unification, making it a key moment in 19th-century European history.
