1. Which sequence is associated with Kodály's approach?

A. Prepare, Present, Practice

The sequence used in the Kodály approach is: Prepare, Present, Practice. The method begins by preparing students—warming up the voice, ears, and body with designed listening and singing activities so they're ready to grasp new musical ideas. Next comes the presentation, where new concepts are introduced through accessible songs, solfège (do-re-mi) and hand signs, making pitch, rhythm, and musical relationships tangible in a friendly, musical context. Finally, students practice what they've learned through guided repetition, singing activities, and games, which solidifies the skills and builds fluency before moving on to reading or more complex tasks. This order fits Kodály's emphasis on singing as the primary route to musical literacy and on structuring lessons so concepts are heard and internalized before formal notation or broader performance challenges. The other sequences don't align with that flow or the central focus on vocal-auditory learning first.

2. The Baroque Period is defined as which approximate time period?

The main idea is that Baroque music spans roughly from 1600 to 1750. It began around 1600 with the rise of new expressive styles—opera, figured bass, and richly textured ensembles—and developed through mid-18th century, ending as the Classical era's clearer forms and balanced aesthetics came to the fore, around 1750. That time window best captures the period's characteristic innovations and stylistic trajectory. Why the other options don't fit: 1500 to 1650 sits mainly in the Renaissance era, before the Baroque style emerged. 1650 to 1800 extends too far into later Classical tendencies and into the Romantic era, which is later than Baroque's traditional end. 1700 to 1800 starts too late for the Baroque's beginnings and ends beyond its typical close.

Tempo markings convey speed and character, and they sit in a rough order: Largo is very slow and broad, Adagio is slow and stately, and Larghetto sits between them as a broadly slow tempo. The description “rather broadly around 60-66 bpm” matches the common metronome range used for Larghetto. This term literally suggests a tempo that’s slower than walking but not as slow as Largo, giving a calm, lyrical feel. Adagio tends to be a touch faster (and more substantial in character), often around a bit above that range, while Largo is typically slower still. So the range around 60-66 bpm best corresponds to Larghetto.

Partita designates a collection of dances, often used as the title for Baroque dance suites. A suite groups multiple dance movements into one work, so the partita represents the entire set rather than a single dance. In this context, other terms refer to individual forms: a prelude is usually an introductory piece; a musette is a specific rustic dance style sometimes included in suites; and a ricercar is a contrapuntal instrumental piece, not a dance within a collection.

5. Friction idiophones produce sound by rubbing, and include which instruments?

Friction idiophones produce sound by rubbing, which excites continuous vibrations through friction rather than by striking or plucking. The musical saw is played by sliding a bow or rubbing the blade with a finger to make it vibrate, yielding a sustained, singing pitch. The glass harmonica creates tone by rubbing wet fingers around the rims of glass bowls, also relying on friction to excite the glass. In contrast, the xylophone and marimba are struck instruments (sound from hitting wooden bars), the snare drum uses a vibrating drumhead (membranophone), and the pan flute produces sound from vibrating air in a column (aerophone). So the instruments that fit friction idiophones here are the Musical Saw and Glass Harmonica.

6. Which instrument transposes down a major sixth from written treble?

Transposing for instruments in E-flat means the sounding pitch is a major sixth below what is written. In other words, you write notes a major sixth higher than the concert pitch you want. For an E-flat alto clarinet, written C sounds as concert E-flat, a major sixth lower. So this instrument transposes down a major sixth from written. Among the options, the alto clarinet in E-flat fits this exactly, while Bb instruments (bass clarinet and soprano sax) transpose down a major second, and the oboe sounds at concert pitch (no transposition). Therefore, the instrument that transposes down a major sixth from written treble is the E-flat alto clarinet.

Tone color and atmosphere define Impressionism in music. Debussy is a prime example, crafting a sound world through shimmering timbres, delicate orchestration, and harmonies that glide rather than push forward with overt drama. He often uses whole-tone scales and modal flavors to soften traditional tonal pull, creating a watercolor-like effect where color and texture carry the mood. This emphasis on color and mood over strong developmental drive is what links him with Impressionism. Beethoven emphasizes formal structure and dramatic development, Chopin centers on expressive piano melody within Romantic sensibilities, and Stravinsky moves into newer modernist language with rhythm-driven contrasts; Debussy remains the closest associate of Impressionism because of tone color and atmospheric texture.

Reverberation time rises when a space is large and has many hard, reflective surfaces that bounce sound around instead of absorbing it. Cathedrals and large concert halls fit this description: they have vast volumes, high ceilings, and materials like stone or plaster that reflect sound rather than soak it up. With few absorptive finishes, the sound energy persists as multiple echoes and reflections decay slowly, producing a long reverberation tail. Open fields and outdoor stadiums lack enclosed boundaries, so sound dissipates quickly into the open air and doesn't build a prolonged echo. Small practice rooms are compact and often finished with absorbent materials, which shortens any lingering sound. Therefore, the environment associated with the longest reverberation time is cathedrals and large concert halls.

9. The technique of altering the tone color of a single note or musical line by changing from one instrument to another in the middle of a note or line

Klangfarbenmelodie is the idea here—the melody is shaped by changing the tone color, distributing the same line across different instruments mid-note or mid-phrase. Rather than keeping the line on one instrument, the musical line is handed off to others, so the pitch and rhythm stay the same but the timbre continually shifts. This creates a contour defined as much by color as by pitch, a hallmark of early-20th-century experimentation. It's not about timbre alone—the term describes using changes in timbre to carry the melody itself. It's not about dynamics (loudness) or texture (how many lines or voices there are), though those elements can be affected as the line moves between timbres.

10. In musical analysis, the term antecedent is defined as which of the following?

Antecedent is the opening portion of a musical period. It presents the main idea and typically ends with an inconclusive cadence, creating tension that leads into the following phrase, the consequent, which provides a stronger sense of resolution. In a fugue, the opening presentation of the subject can function as this initiating material, serving as the antecedent by establishing the tonal area and melodic material that will be developed before the ensuing material offers cadence and contrast. That's why the best description identifies the first phrase of a musical period and notes, in contexts like a fugue, how the subject can play that initiating role. The other options describe unrelated ideas—a short light piano piece, or the second phrase of a period (the consequent)—which do not match the function of the antecedent.
