When a licensee is granted inactive status by the Board, it means their license is temporarily not active. During this time, the licensee is not required to complete the continuing competency hours (option A) or retake the Board Exam (option B). However, they must still renew their license within the same time period as if it was active (option C). This is a crucial step to ensure that the license does not expire and can be restored to active status when needed. Option D (none of the above) is incorrect because as mentioned above, the licensee must still renew their license during the inactive status.

2. What does Article 11 relate to?

- A. PTA application procedures**
- B. Fees for PT/PTA licenses and exams**
- C. EMG certification**

Article 11 relates to EMG certification, which is a type of medical test that measures the electrical activity in muscles. This option is correct because EMG certification is specifically mentioned in the text. The other options are incorrect because they are not mentioned in Article 11 and do not relate to EMG certification. Option A, PTA application procedures, could be misleading because PTA stands for Physical Therapist Assistant, while EMG stands for Electromyography. Option B, Fees for PT/PTA licenses and exams, is incorrect because Article 11 does not mention anything about fees related to licenses or exams. Option D, Partnership agreements for professional corporations, is incorrect because Article 11 does not mention anything about partnership agreements or professional corporations. Therefore, the best answer for this question is Article 11 relates to EMG certification.

Therefore, option C, 30 days, is the most appropriate choice as it allows for sufficient time for preparation and resolution.

10. Under what condition can privileges of a PTLA be lost?

PTLA stands for Physical Therapy Licensure Authority, which is the governing body for physical therapists. As a physical therapist, it is important to maintain the necessary qualifications and obtain a license in order to practice. Option A is incorrect because renewing the application annually is a necessary requirement but it does not lead to loss of privileges. Option C is also incorrect because physical therapists are trained to work without direct supervision. Option D is incorrect because receiving a complaint from a patient does not automatically result in loss of privileges, it may lead to further investigation. Option B is correct because not taking the next succeeding exam or obtaining a license shows a lack of commitment to maintaining the necessary qualifications, which may result in loss of privileges from PTLA.
