- 1. What is the term for the situation in which one force does not have air superiority over others?

Air denial refers to an operational goal aimed at limiting the enemy's use of airspace, without necessarily achieving outright control or superiority.

While the other options address significant themes related to Vietnam during or after this period, they do not accurately reflect the direct outcome of the communization event itself. For instance, the establishment of a democratic government did not occur under the communist regime, and while the end of US military involvement was a result, the focus of the correct answer is specifically on the war's conclusion. The rise of a humanitarian crisis became more pronounced afterward but is not as direct an outcome of the event in the context of the question.

3. Which body is in charge of approving the appointment of the SECAF?

The Senate is responsible for confirming the appointment of the Secretary of the Air Force (SECAF). The Department of Justice is involved in legal matters but does not have a function in the confirmation of the SECAF or similar appointments. Thus, the Senate's involvement is key in ensuring that the appointee is qualified and suitable for the role.

Dominating ground forces, although relevant, does not address the unique operational environment of space and its influence on mission execution. In contrast, ensuring continuity directly aligns with the essence of maintaining control over space assets and operations, affirming its significance in overall military strategy.
