Immediate rewards for inappropriate force use contradict the principle of accountability and responsible decision-making in high-stakes environments where use of force is carefully regulated. Furthermore, expressing representation for a community doesn't provide the requisite details of military or federal service which are crucial in establishing one's role and responsibilities within a protection mission setting.
