This moment tests Wilde's knack for turning a small, practical action into a burst of humor that reveals character. Algernon wants to carry Miss Prism's address with him in a way that's quick and clever, so he writes it on her sleeve rather than risking loose paper or asking again. The sleeve becomes a playful, almost theatrical place to store information, matching the play's light, farcical tone and Algernon's improvisational, self-serving style. It shows his tendency to treat everyday details as opportunities for wit. The other options don't fit the scene: there isn't an erasing, copying, or forgetting of the address happening here; the action actually depicted is writing it on the sleeve.

2. How does the title's pun on 'Earnest' function thematically?

The main idea being tested is how the title's pun on Earnest exposes a link between sincerity and identity, revealing social performance and deception as central to the play's themes. The name Ernest sounds like the word earnest, so Wilde uses the pun to show that being "serious" and "honest" in society can be a mask people wear to gain approval, status, or romantic advantage. In the play, characters adopt the name Ernest to live as if they are genuinely earnest and trustworthy, highlighting how much of social life hinges on appearances and self-fashioning rather than true virtue. The humor comes from the mismatch between what the characters profess to be and what they actually do, which undercuts the easy equation of honesty with social respectability. The title then signals Wilde's satirical critique: earnestness is less a fixed truth than a performative social role. This interpretation fits best because it explains why the pun matters beyond surface jokes: it foregrounds the tension between sincerity and deception that drives the plot and the social commentary. The other options miss that broader thematic frame, either reducing the effect to pure comedy, miscasting the stakes, or focusing on a single premise rather than the larger pattern of social performance.

Her behavior—policing who is suitable to marry and treating family alliances as strategic investments—clarifies her role as the satirical engine that exposes the absurd seriousness with which the aristocracy clings to status and respectability.

Miss Prism is a guardian of proprieties in a domestic sense, Lane provides satire through servant wit, and Canon Chasuble represents clerical pomp—useful to the play's humor, yet not the figure enforcing marriage standards for society at large.
