This definition captures the multi-faceted impact of colonialism, making it clear that the intent was not merely to exploit for short-term benefits or tourism, but to thoroughly integrate the colonized territory into a broader empire, often with lasting consequences that can still be observed today.

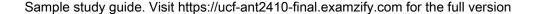

Naturalistic could describe representations in art that mirror the natural world, but religious symbols often transcend this limitation by incorporating abstract, spiritual, or philosophical ideas that cannot be easily categorized as simply naturalistic. Thus, multivalence is the most fitting descriptor for the depth and variety of meanings that religious symbols can embody.
