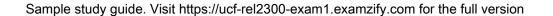

Reaching heaven is a concept more commonly associated with Abrahamic religions and does not encapsulate the central aim of Buddhism. Enhancing good karma is indeed important within the context of Buddhist practice, as it can facilitate positive rebirths; however, it is not the ultimate goal in the way
