## **Explanations**

**1. If driving speed is doubled, how much greater is the force of collision?**

- A. Twice as great**

When driving speed is doubled, the kinetic energy of the moving vehicle, which is directly related to the force of collision, increases by a factor related to the square of the velocity. Kinetic energy is calculated using the formula  $(KE = \frac{1}{2}mv^2)$ , where  $(m)$  is mass and  $(v)$  is velocity. When the speed is doubled, the new kinetic energy becomes  $(KE' = \frac{1}{2}m(2v)^2 = \frac{1}{2}m(4v^2) = 4 \times \frac{1}{2}mv^2)$ .
