**1. Is emergency contraception covered by the Affordable Care Act?**

- A. Yes, without prescription**

While it is true that emergency contraception is indeed covered by the Affordable Care Act, option A is incorrect because a prescription is still required. Option C is also incorrect as the ACA does cover emergency contraception. Option D is also incorrect because both brand name and generic versions of emergency contraception are covered under the ACA.

**2. In nursing homes, CSA Schedule must be on the label for dispensed drugs to patients?**

- A. True**

- C. Only for Schedule II drugs**
- D. Only if the drug is a controlled substance**

In nursing homes, all dispensed drugs must have the CSA Schedule (controlled substances' classification according to the Controlled Substances Act) clearly stated on the label to ensure proper administration and tracking of controlled substances. Even though it is mentioned in some of the other answer options that the CSA Schedule is only required for certain types of drugs (Schedule II or controlled substances), this is not the case. For any medication that is dispensed to patients in a nursing home, regardless of its classification, the CSA Schedule must be included on the label. Therefore, the correct answer is A.

Options A, C, and D are all examples of prescription errors that pharmacists should take action to correct to ensure patient safety.

Minors 14 or over in Washington state can consent to treatment for STDs without parental permission. This may seem surprising, as most medical procedures typically require parental consent for minors. However, Washington state law allows minors to seek treatment for certain sexual health conditions without informing their parents. Options A, C, and D are incorrect because minors still need parental permission for medical treatment, vision tests, and dental procedures, unless the treatment is for STDs.
